Phenylpropanolamine Hydrochloride is toxic when overdoses are ingested. Adverse effects may include dizziness, headache, nausea, insomnia or restlessness, and increased blood pressure. The usual oral adult dose of phenylpropanolamine hydrochloride is 25 mg every four hours, not to exceed a maximum of 150 mg in 24 hours.
